Applicants must complete the award category form to enter an award. Entrants may enter unlimited award categories; however, all submitted entries must be tailored to each individual category.

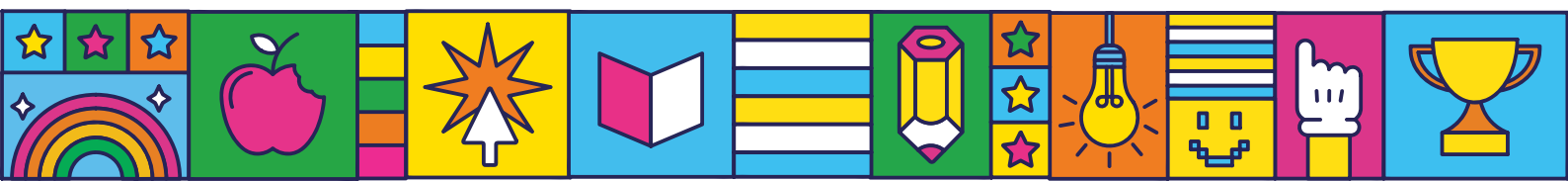
### Winner selection and notification
