

## Terms and Conditions – Win an Author visit. Reading Plus Book Review Challenge 2024.

By entering this competition, you agree to be bound by these terms and conditions:

### 1. The sponsor

The Sponsor of this competition is Reading Solutions UK, a company registered in England no. 09284598 ('the Sponsor'). This competition is not sponsored, endorsed, administered by, or associated with Facebook, X, Instagram or any other social network.

### 2. Eligibility

The competition is open to current Reading Plus licence holders. The competition is open to schools in the United Kingdom. There is no entry fee and no purchase necessary to enter this competition.

### 3. The competition

To enter the competition, schools must register to take part in the competition on [www.readingsolutionsuk.com](http://www.readingsolutionsuk.com). Students must submit a book review based on a book of their choosing using a template provided by Reading Solutions UK.

If book reviews are entered by a parent, carer, or guardian, they must have confirmation from the child's school that they would be willing to receive the prize if they win the competition.

### 4. The prize

Three prizes will be awarded:

- **Prize (1)** Local author visit.
- **Prize (2)** £100 Amazon voucher and a certificate.
- **Prize (3)** £50 Amazon voucher and a certificate.

Prize 1 – Local author visit. This prize will be arranged between The Sponsor and the winning school. The prize will be up to the amount of £400. The local author may do a physical or virtual workshop with the winning class. This will be arranged between The Sponsor and the local author. The winning school may suggest local authors they have a relationship with to The Sponsors. However, The Sponsor cannot guarantee that this will be the chosen local author to complete the visit.

### 5. How to enter:

Schools must submit their book reviews through [www.readingsolutionsuk.com](http://www.readingsolutionsuk.com).

Only one entry per student will be accepted (submissions must include the student's name, age, and school).

Poem entries must be submitted by midnight on Thursday, the 28<sup>th</sup> of March, 2024.

All entries must be received before the competition closes to be eligible. No responsibility can be accepted for entries not received for whatever reason.

## 6. Winner selection and notification

- The competition closes at midnight on Thursday, the 28<sup>th</sup> of March 2024.
- Reading Solutions UK will select three winners.
- Winners will be notified on Tuesday, the 16<sup>th</sup> of April, via email and shared on our social media channels.
- The winners will be sent the appropriate prize. No cash or other alternatives will be offered.
- If the prize notification email is returned as undeliverable, this may result in disqualification or forfeiture of the prize and the selection of an alternate winner by the Sponsor.
